I understand that if I do not pay the full amount due under this dining dollars contract, or any other amount due on my student account, I will be responsible for all costs and expenses associated with the collection of such unpaid amounts, including the fees of any collections agency, which may be based on a percentage of the total balance due (up to a maximum of 45%) and reasonable attorney fees.
