Blue Ribbon Committee on the CTRs and Peer Observations

RE: Draft of the modified CTR items

The Blue Ribbon Committee on the CTRs and Peer observations was empaneled in December 2020 by the Provost and the President of the AAUP to review the CTR policy and items. The committee surveyed chairs, faculty, and students in Spring 2021 to uncover the dimensions of teaching and learning that ought to be represented in an instrument for students' assessments of their courses. Based on these surveys, the following draft items were generated to reflect a broad array of teaching dimensions—assignments, instruction quality, course climate, and amount learned—that were judged to be helpful for a faculty member's professional development as an effective instructor.

We believe the data from the draft CTR will be most useful for faculty development if data from the first 12 items are reported separately, rather than grouping items into subscales (i.e., overall, workload, grading, and interaction) as is our current practice. We designed the current CTR to broadly survey important teaching factors – nuanced information that would be lost if these items were averaged.

Nonetheless, the final two items—overall instructor rating and overall course rating—may be averaged to create a single overall rating that will be useful for both faculty summative feedback and for personnel matters.
