- 2. If the number in household and/or college you are reporting now on the Verification Worksheet does not match the number(s) you reported on the FAFSA, submit a written statement of explanation which must be **signed by both student AND parent.**
- 3. Submit 2009 signed Federal Tax Return(s) and W2 forms for both parent and student, if filed. Do not submit originals, we must retain copies in the student file; unnecessary pages will be shredded. If you do not have a copy of your return, you may request a tax transcript by calling the IRS at 1-800-829-1040. NOTE: All forms submitted (including those filed electronically, prepared by a tax preparer and tax transcripts) must have a wet signature.
- 4. Submit Schedule E of 2009 Federal Tax Return(s), if filed.
