Comptroller Greenlaw: So for example, even if I was Political Science Major, I still could go and join Women In Music if I wanted- there is nothing prohibiting me GPA wise, like an honor society, from joining. We could add language to return the Victory Fund back to account for other non-sport organization competitions.

- III. Collaborative Business:
 - A. BLAC → What is their place within SGA? Is it more beneficial to make them their own organization outside of SGA? We are thinking yes. Current plan is to keep the advocacy branch until they are fully recognized as their own organization and then get rid of the branch completely. It would lessen the workload for them as well as us both financially and
 1. Chair Skeldon: With their current state, we can only fund things related to their advocacy, and nothing outside of that- and they have great event ideas for events that we constitutionally cannot fund.
 2. Chair Mahlati: It is also a concern that they have no institutional memory, meaning they always have to go through someone else, meaning us, which is a concern for members and the longevity of the organization.
 3. Chair Young: What are their current responsibilities under SGA?
 - a) President Anniballi: They are supposed to attend a committee meeting each week as well as attend at least one senate meeting a month.
 4. Chair DiSanto: So for them, what is the next step?
 - a) President Anniballi: Encouraging them to become their own organization that can be recognized by OSLE and SGA. Or, have them fall under the IEI office.

5. Chair Young: It also is a concern because proper process means if they want more funds from SGA, it would have to then be branded as an SGA event rather than a BLAC event, which is unfair to their work.
6. VP Joyal: I know we spoke about how we could fast-track their recognition. I think a concern for this is that they don't know how to function as an independent organization. I think they need to learn how to work as an individual group, and get their "ducks in a row."
 - a) President Anniballi: Yes, and I do think that doesn't mean we have to cut them off completely. We should provide support to them during this time, but with the goal of moving them forward. But as of right now, there is some pushback from BLAC itself.
 - b) Chair Young: Where is this pushback coming from?
 - (1) President Anniballi: Originally they were on board, but after deliberating with their leadership they seem frightful about moving forward as a separate organization.
 - (2) Chair Mahlati: This is definitely something that has to be treated delicately.
 - c) Chair Young: Yes, I feel like what they are working on currently isn't actually advocacy based as intended. It brings to question how BLAC is different from other organizations like BSU. As of right now, it does not seem like they are in favor of becoming separated.
7. Chair Mahlati: So, what would be the next step?
 - a) President Anniballi: I think the next step is that we need to start writing legislation that would make them an independent organization. And sooner rather than later, so we can help prepare them for the recognition process.
 - b) Chair Quali: Totally agree. We need to get on this because they frankly will be treated with backlash and pushback from OSLE for recognition. We need to find a way to support them with that.
8. Chair Vickers: To take a step back, I know budgets are a main reason. Why don't we explore options that change how their budgets are done, rather than "kicking them out?"

9. Chair Danek: I think right now their events, as mentioned, are not advocacy based- like panels or town hall to address national or school wide issues- rather than social issues. I think SGA needs to help promote these events to allow them to get their footing as an individual organization.
10. Chair DiSanto: Do they have to separate from SGA prior to going to recognition?
- a) President Anniballi: No, they can do it all at the same time. They can go through that process, and we will remove them from the branch after being recognized.
 - b) Chair Quail: I would hesitate keeping them under us during this process, aside from their budget. I think we don't need to get rid of them completely, but it would be unfair to other self-identifying organizations for this 'preferential' treatment.
 - c) President Anniballi: Agreed. I think this is also something that can be added into policy; maybe we write language in our constitution that requires Equity to collaborate with BLAC or other identifying organizations.
11. Chair Skeldon: I wouldn't be opposed to their budgets coming from SGA external budgets if that makes it easier for us and them. But we have to look more at policy.
- a) Chair Mahlati: Even if that is the case, they are being funded to plan events that are outside the scope of their mission statements, which isn't a fair use of our budget.
 - b) President Anniballi: Yes, we would have to look over policy.
12. Chair Young: Could we just revise the policy?
- a) Chair Quail: It would just cause issues regarding other identifying organizations- why does this advocacy based club get put under our umbrella?
 - b) Chair Young: But, isn't the main issue just the fact that we cannot fund them because their events are not in line with their mission. Why can't we just sit down with them and make sure they know what they have to host and plan. What do we do if they still oppose?
 - (1) President Anniballi: I think this is where a conversation with them takes place. I don't know if it is necessarily

opposition, or just a question as to why it would be beneficial with them. I think we need to discuss with them first, but I think we need to update the External Advocacy Branch as a whole and what that actually looks like for SGA and recognized organizations.

(2) VP Jewels: Yes, we see the back end of it for budgets and paperwork, so they may not see the “rule bending” we are doing for their organization. That is why we need to sit down with them and lay it all out. If they aren’t following our policies, there needs to be repercussions.

(3) President Anniballi: Exactly. There have been numerous records of the breaking of expectations or policies that, despite our corrections and help, do not put effort to correct these mistakes. I think a part of it though is just the confusion of the policy. It needs to be organized.

B. Stage in HofUSA: We helped with the HofUSA renovations. Part of our recommendation was a new stage; facilities did not budget for it and now want us to pay for it. What do we all think?

1. Chair Danek: I think a stage would be beneficial for organizations like Hofstra Concerts, and so on.

2. Secretary Egolf: While I think a stage would be beneficial, I don’t think it is our responsibility to pay for it because we advocated for it. I think if they won’t be funded, the space is fine as is. The open floor plan could still allow for various events regardless of the stage; you can still have concerns or fashion shows that would work with the way chairs or tables are set up. Makes it easier for events like Pride Expo.

3. Chair DiSanto: If we don’t fund it, will someone else pick up that payment? Do we have the money for it, and would it take away from club funding?

a) Comptroller Greenlaw: It would not affect clubs. If we did, we would take it out of our Capital Fund. But, it would drain half, if not more, of that fund. This could be used towards

something more beneficial, as the space would still work without it.

- b) President Anniballi: I think if we continue to advocate for the importance of it, but continue to reiterate that it is not our responsibility to pay for it, we could possibly get it funded through facilities.
- c) Chair Quail: I think our best bet is to hold off on this fund for now. If we continue to advocate for its fund, and it gets picked up, great. If not, and in a few years students have expressed continuous interest or want for a stage, I think SGA can circle back and think about funding the stage.

C. Housing Concerns with Registration

- 1. Comptroller Greenlaw: I think as far as homesteading, and as far as medical concerns, they have lost reservations and students were placed in different rooms, sometimes unaccommodating.
- 2. Chair Vickers: I heard a lot of people switching rooms around, and that there are certain ResLife higher-ups that are not friendly or helpful to students.
 - a) President Anniballi: Agreed. Sometimes you'll ask for a request, like to homestead, and they tell you that you did it wrong, but won't tell you the correct way.
- 3. Chair Quail: I know room request changes are also really difficult, as far as forms getting lost and lack of response. They send you on a wild goose chase.
- 4. VP Joyal: Room availability is also an issue. Some people would request different rooms and then were given other rooms. I think if there was more transparency as far as how many rooms are available in each dorm on their website, they can dedicate more time to other concerns.

D. Election: We seemed to have a voter-turnout problem. Only about half of possible electors received the precedent minimum number of votes. We would turn away 9 people, and would not have a full senate. We spoke to J-Panel has decided that the policy regarding elections is unclear, needs to be addressed and amended immediately, and the decision remains up to us. With that said, the 20 people with the highest votes will be sworn into the

Senate. The remaining 3 people will become Senator-Elect and can fill vacant seats when or if they become available.

1. Chair Vickers: Do we think that the students didn't vote because it was so competitive and only voted for some people.
 - a) President Anniballi: That is a possibility.
 2. Joyal:
 - a) I know for me I voted very particularly, reading bios and such; maybe people did not vote for people because they just don't want those people representing them. Why do we have the power to overturn what the school population may want?
 3. Comptroller Greenlaw: Do we think that a lack of tabling or maybe a lack of email could explain a lack of voting?
 - a) Chair Danek: I also think that first years may not know what SGA is, and are weary to vote for something they don't fully understand.
 - b) VP Joyal: I also think the platform that it is on is an issue. It is on the portal, but in reality the portal is not very useful or accessed unless you are maybe clocking in for work. I think we should look into different platforms.
 4. Chair Nimba: I think we need to look into what is in front of us. First, lack of communication via tabling or emails. Second, we need to look at the numbers of the 8 people- if there is a very large disparity between them and students who did meet the vote limit, that should not be ignored.
 - a) Chair Quail: The issue is that I am worried Sev will not give us the numbers in general. That is what J Panel discussed, but that is an issue in itself. We are working on getting those numbers now.
 - b) VP Joyal: A disparity is always possible, even in those who make the threshold, regardless of what the vote count is. That is why a disparity does not necessarily prove anything. The issue is the language needs to be changed to prevent this.
 5. Chair Skeldon: The results are the results. I don't think we need to update it and rush by tomorrow. I think it can wait for tomorrow.
- E. ASGA: Do you all think we should resubmit our dues and become active again in this organization?

1. Comptroller Greenlaw: Yes, I think so. I think that us being a part of that would be a bigger scale version of the conference we held last year. I think it would be beneficial for us.
2. Chair Danek: I can see good reasons to pay our dues, but if it involved funding for travel and such, is that really reasonable for us? If there are other benefits, I think it would be a good idea.
 - a) President Anniballi: There are tool packs, networking opportunities, and other educational opportunities.
 - b) Comptroller Greenlaw: We could also use Capital Fund or donated funds for trips like that if we found it beneficial.
3. President Anniballi: Dues are also not that expensive. They may also waive the fee for a few years, so it would be feasible.

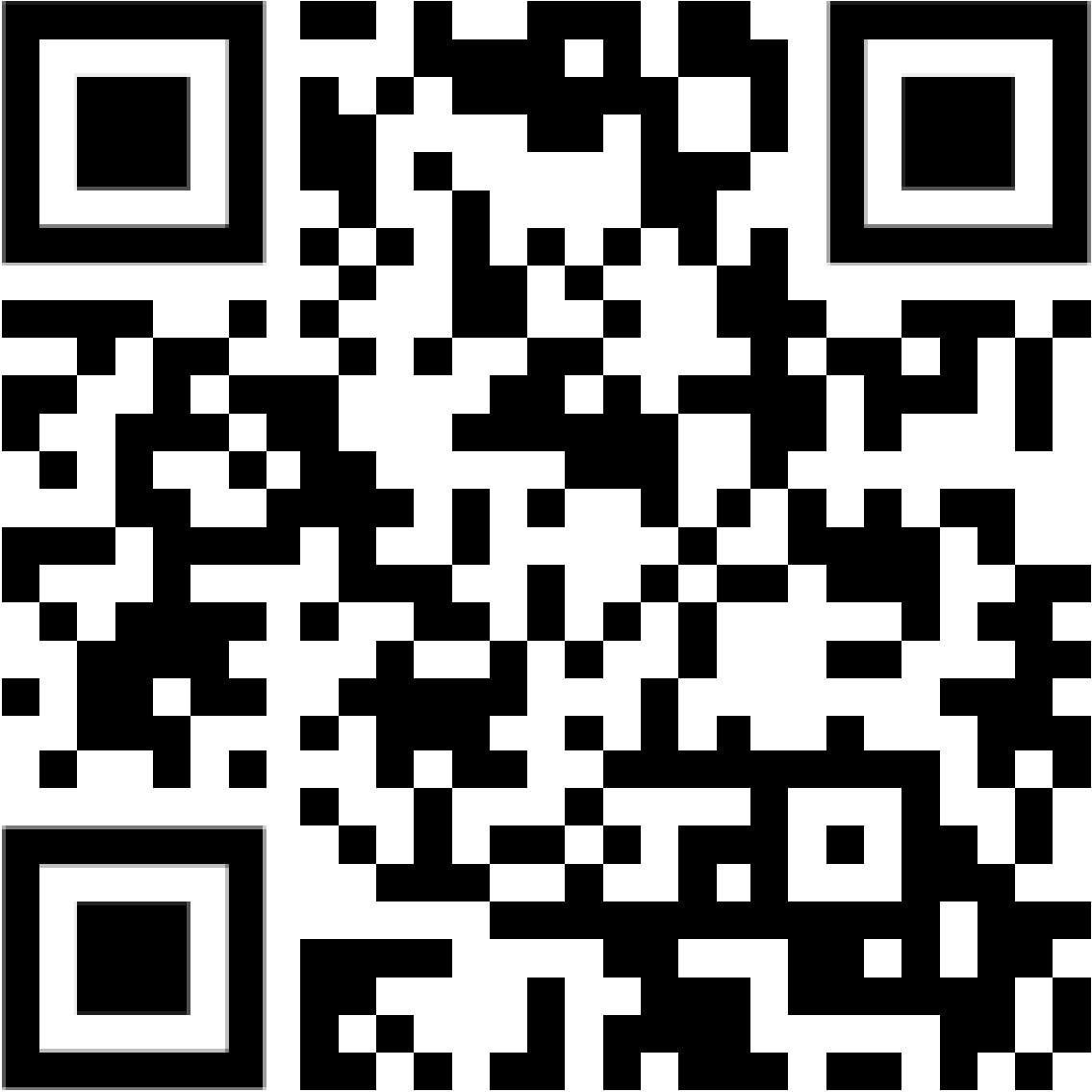
