- a. Senator Callahan moves to open the gallery
 - i. Motion seconded

b. Welcome BLAC

- i. BLAC Presentation
- ii. President Anniballi: For our new members, in 2022, BLAC was looking for a non-administrative route for their organization. This was then supported with the External Advocacy Branch, which BLAC now sits on the branch. They are fully under us, as far as resources, but also independent with events and members.
- iii. Chair Mahlati: Biggest Accomplishment?
 - 1. BLAC SGA Liaison Kidd: Personally, my biggest is BLAC Eats. I have been working on growing this event for the past three years, and have been in this organization since my freshman year. We are even looking into having a "party" with Compass to expand BLAC Eats even more. Also the Real Lounge, that is a great community space for our members and members of other organizations utilize-especially with our large commuter population.
- iv. Chair Young: How are you incorporating incoming members into your orgs, your demands, and your advocacy while a majority of your members are graduating?

- 1. BLAC SGA Liaison Kidd: I think it all stems down to our core demands. This org is an ever-changing environment. It is always shifting and changing with the times. So of course, we can share what we are working on and what inspires us, but it does change and I think
- v. Chair Vickers: How are you supported by faculty, staff, and compass?
 - 1. BLAC SGA Liaison Kidd: I think we receive pretty good support. We have support from Dean Christy, especially with Compass relations. We also receive help and support from black faculty members, who attend meetings and help us with some of our agenda and demands.
- vi. Senator Yari: Do you also explore events in Africa, or just events in the US?
 - 1. BLAC SGA Liaison Kidd: For the majority, we focus on events and issues within the US. As an advocacy body, though, it is our job to push the envelope and look into and advocate for those issues as well. We receive some pushback from some, but it is a goal.
- vii. Senator Guenfoud: Could you talk about the expansion of the Black Studies Major?
 - 1. BLAC SGA Liaison Kidd: I can't speak on it fully, I am not personally a part of this Major. I think the main goal at this point is not only expanding it with course material, but also just making people aware that this is a possible major option for them.
- viii. Chair Danek: What is the major advocacy goal this semester?
 - 1. BLAC SGA Liaison Kidd: Our main priority is definitely with voting efforts. We try to stay as nonpartisan as possible, but it is our goal to help get as many students registered and voting, but specifically black students. A lot of us come from political backgrounds, so this is our priority right now.
- ix. Chair Mahlati: Have you talked to the administration about the federal Affirmative Action laws?
 - 1. BLAC SGA Liaison Kidd: We have not. It happened over the summer when we weren't here. It is definitely something we can look into. But, we feel like Hofstra has made it clear to continue with an inclusive and diverse admission process.
- x. Senator Miranda: Do you have a working strategy to acknowledge student grievances- do they come to you with concerns or issues they may have experienced? How has it worked out so far?

- 1. BLAC SGA Liaison Kidd: Yes! We have a google form in our instagram bio for people to submit concerns or discrimination regarding their race.
- xi. Senator Callahan: Can you talk about issues you have run into with higher admin or the board of trustees.
 - 1. BLAC SGA Liaison Kidd: I wouldn't say we have a lot og issues with them. But, one example was with the Thomas Jefferson statue. We wanted it moved off campus, but because it was donated by a major benefactor, we had to come to the agreement to move it to a more secluded location.
- xii. Senator Scott: How do you think the election will affect black students?
 - 1. BLAC SGA Liaison Kidd: I think it defienly will. And we haven't looked into that much with direct ideas yet. But, I thank you for bringing that up because we do want to come up with some events and support resources.
- xiii. President Anniballi: What has been your biggest win? How can students get involved?
 - BLAC SGA Liaison Kidd: I think the biggest thing, which is still in the works, is the Racism in the US course. We have been really pushed for this, and seem to be at a standstill. Part of that may fall on us, but primarily we have had some pushback getting this course to be mandatory. To get involved, I would say to go to our instagram. We have a google form to sign up. Also, though, get involved with other Black orgs, as there is alot of member overlap. We try to see ourselves as the connector between all the black organizations. To bring their concerns to administrators in a way that may be faster.
- xiv. Chair Young: What is the best part of being under SGA? What else can we do to amplify voices?
 - 1. BLAC SGA Liaison Kidd: I think SGA is great with getting outreach. There are a lot of our events, you help with booking and especially with marketing. You make sure we get our spaces, and really help promote turnout. I think amplifying voices really is just as easy as following us, reposting our events, and supporting our Core members.
- xv. VP Joyal: Can you expand on some of the collabs you have had in the past?
 - 1. BLAC SGA Liaison Kidd: We have a lot of members who are RAs, which connects us to ResLife, especially with the Umoja

Scholars LLC. Also, with some of the black greek orgs, they are a vital part of our programming and support.

- xvi. Senator Yari: How do you advocate for people in other situations around the world? Would you be involved with Compass' teaching kitchen, as I think the next one is teaching Jamaican food.
 - 1. BLAC SGA Liaison Kidd: I know there are things going on around the world that BLAC could be a voice for. It isn't something we have done, but definitely want to see how our organization can help with these. We would love to. I was unaware, but I think that would be something we would love to be attached to, as it kind of stems off BLAC Eats.
- xvii. Senator Thani: Getting involved with sophomores and freshmen as upperclassmen-heavy org?
 - 1. BLAC SGA Liaison Kidd: It is more than just an org. I think that is our main emphasis. You get something different out of BLAC than you do in any other club or organization.

 - 1. BLAC SGA Liaison Kidd: This demand is hard. This is really where we need help from our Black Faculty Council is working towards, and we want to support them as much as possible in this goal.

 - BLAC SGA Liaison Kidd: We are working with black mental health alot, it is our main goal. We have advocated for getting black staff members in SHS that can handle and relate to black trauma. Our own space is The Real Lounge, right next to the SGA office. It is a space where the black community can come and feel welcome, and many of our associated orgs host their meetings there.

 - iii. Chair Vickers: I understand the point of wanting a snap cup, but after the meeting. If that is the case, it would lessen the impact. My first few senates, snap cup was a really big part of me. We can always strike it if we don't want it or if we are having a long senate. We should be prioritizing our responsibilities before Senate, because you know it can go late.
 - iv. Comptroller Greenlaw: Snap cup does not have to be an every single meeting. We can always strike it. A lot of you all are new, it acts as an icebreaker. It kinda brings in some lore that newer members don't have. It kind of lessens the harshness of this administrative setting.
 - v. Chair DiSanto: It takes five minutes. It is not that long, and it's fun! Where is the whimsy? We make jokes, and add fun to the meetings.
 - vi. Secretary Egolf: Past senators in prior years have gone long past midnight. We do not do that, but we understand how tiring that can be. Snap cup doesn't take that long and we as an e-board understand and are willing to work with people. Especially based on the fact that you can all move to strike it at each meeting. And if you feel that way, likely others do too.

- III. Collaborative Business:
 - A. What determines the dress code? Concerns for "business casual."
 - 1. Secretary Egolf:
 - 2. Comptroller Greenlaw: Completely agree. Especially for student groups- I think that it establishes a weird power dynamic between us despite both being student organizations.
 - 3. Chair Danek: I think it is important to show our best when meeting a club or new organization who may be presenting. I don't necessarily think it needs to be business casual, but on a case to case basis, maybe enforce no sweats.
 - a) Chair Mahlati: While I get it, many of these orgs, whether we have met with them directly or not, they share offices with us and we see them. We are with them.
 - 4. Chair Skeldon: I agree, I don't think that we need a dress code for student orgs, or even some administration with exceptions.
 - 5. VP Joyal: While I see the point of not dressing up for students, I do think that we should dress up for administrators to show that we do serious work and deserve the respect from them. I think a dress code shows that.
 - 6. Chair DiSanto: I get a little bit of both. I think in certain situations business is needed. But, I also think that a general idea of dressing

nice- no ripped jeans, or crop tops, etc- would work well in most cases.

- 7. VP Joyal: I see both sides. I think there are times and places for formal wear to show a sense of respect, not only to guests but to yourself. I think other cases when we want to seem like a mutual, for student orgs for example, a more casual clothes would make us seem more approachable.
- 8. Chair Mahlati: I think my intention is getting lost. My intention was the idea that we are, and senate, is often seen as a tense or scary place. I think how we present ourselves, especially with clothing, can help bridge that gap.
 - a) President Anniballi: Exactly. And that goes not just to dress code but in general with how we present ourselves as an organization. We should be wearing our name tags, for example, not as a symbol of importance, but rather to emphasize that we are a resource.
- 9. VP Joyal: I think in the future I will try to clarify the definition of "business casual," because I think it is getting lost in translation. It seems like we all have the same, similar idea.
 - a) Secretary Egolf: Maybe we can emphasize what NOT to wear rather than what to do- no sweats, no ripped jeans, no crop tops, etc.
- B. Shirley via Phone (Open Gallery)
 - 1. VP Joyal moves to open the gallery
 - a) Motion seconded
 - b) Motion passed
 - 2. Senator Guenfoud: I have heard that the writing center changed its hours- it's only in-person on weekdays until 4pm. This really limits students who may have packed class schedules and cannot make morning/midday appointments. Another issue, someone tried to add a minor, so sought out one of her advisors. This sent her in a circle, chasing down advisors who didn't have answers to her questions or know where to send her. She then had to figure out the minor for herself.
 - a) President Anniballi: Justin has been having ongoing conversations with CUA about advising issues, and I am sure

this will be added to the to-do list. He also is in contact with the new director, and will address concerns and figure out the reasons behind the new office hours.

- b) Chair Danek: I think this has been an ongoing issue, cutting their hours. I will bring it up and outreach to the deans if the new director is unsure.
- c) Chair Vickers: Someone brought this up to me last semester too, so it definitely has been ongoing. Also eliminating the zoom option feels counterproductive, because that is a major resource for students to make it more accessible.
- d) VP Joyal: Some people also take courses that require going, which isn't fair if access is limited.
- 3. Chair Mahlati: I also noticed that they increased the price of summer and winter courses from \$1700 to\$1900 per CREDIT. That does not include housing, eating, etc.
 - a) Chair DiSanto: I also am required to take an internship, which often people do over the summer because they have more time. But, that requires us to pay for those credits.
 - b) President Anniballi: I know Jess has really been spearheading getting 1 free winter or summer throughout your academic career. They also are trying to lessen course loads to eliminate the need for summer or winter classes.

- B. Vice President
 - 1. Adjusting Senate Elect policy to account for people who cannot make the time commitment for a particular semester
 - a) Chair Vickers: I think when writing the policy, it should include a way for CR/Pres to check and confirm conflicts to ensure people aren't abusing that fact. Why are we giving them the privilege of being a Senator-Elect when others who

have to step down for classes the following semester just have to leave?

- Comptroller Greenlaw: I think that is going to have to be specified when we look back into the policy and reestablish what that position is for.
- b) Chair DiSanto: What is stopping someone from running knowing they have a class interference, and then once elected they drop just so they can be a Senator-Elect.
 - (1) VP Joyal: This is moreso to prevent numbers getting too low and dwindling. We may start with a full senate, but people drop throughout the Semester, and we get to the end of the spring and are low on members. That was the intent of that position.
- c) Comptroller Greenlaw: Is there a cutoff for when they can join? Like a deadline in the semester so that Elects are becoming a senator for only 2 senators, for example.
 - (1) President Anniballi: We would have to look into that. There are a few things with that, considering how we currently hold elections. We could consider holding a February election could be beneficial to eliminate some of these concerns- like Senator-Elects being busy on Thursdays when they are finally called in.
- d) VP Joyal: I was not aware we could hold another election. I felt that it was unfair to go through the process, get elected, and then have to wait a whole year. In that case, they can try again the next semester.
- e) Chair Danek: Maybe we can make it an application-like process, where they have to provide a copy of their schedule to ensure they don't have interference. I think associates and senator-elects would both benefit from February elections.
- f) Comptroller Greenlaw: During info sessions, everyone was explicitly told the days and time of Senator meetings and requirements. So it is unfortunate, but they were aware.
- g) Chair DiSanto: So would the February election be just if we have open seats?

- (1) President Anniballi: Yes, it would be the same as Fall elections.
- h) Secretary Egolf: I think that because they are informed, if they reach the point that they can't attend because of class or outside interferences, it at that point is on them. They could have not gone through the process knowing they had interferences, or could have clarified before going through the process. I think Senator Elect could maybe be for those who ran in April, won, and come fall things changes and they cannot stay. They could take the semester off and have a seat in the spring.
 - (1) President Anniballi: Yes, but February elections would eliminate that problem as well.
- i) Chair Vickers: I think we also as leaders have to realize this is a time commitment we have to prioritize if we want, and that might mean blocking out Thursday nights for Senate or reaching out to professors explaining your need for specific class times.
